There were 18 volunteers who attended the annual working bee last October. This was followed by a friendly morning tea in the parish hall with some new faces and familiar supporters. Their help has made a big difference to the appearance of the cemetery.

Genealogy enquiries can now be made using the new **OpusXenta program** which is found on the parish website <u>https://glenosmondanglicans.com.au</u> under 'About us' 'Cemetery' information.

At the Annual Cemetery meeting in July, business included John Moore's bequest to the cemetery. It is to be allocated to the restoration of monuments. As John discussed his ideas with me on many of the Monday mornings spent tidying the cemetery, it will not be difficult to select a number of restorations that will make a great deal of difference to the appearance of the cemetery.

Ellen Hale, who hosted the annual cemetery morning teas in her carport for many years, died in June.

A new cemetery sign will replace the old one by the Glebe Road gate and includes the word "Heritage" to recognise the listing with the Burnside Council. It also includes a QR code that will enable visitors to go to the parish website to access the new computer program. They will then be able to find the graves where family members are buried. The QR code has already had good feedback from the public.



In February the Genealogy Society of South Australia volunteers spent time scanning old Burial Registers, Lease Books and other Parish documents. A digital copy will be available in the parish office and also for those researching their family history in the Genealogy Society library. The safekeeping and preservation of cemetery records is part of the management plan of the cemetery.

Burials/interments since September last year - the burial of Jane Littleton, wife of Revd John Littleton, the interment of ashes of Betty Chalk and a monument for the Mokros family was installed.

The cemetery is a community resource which requires consultation and communication with all stakeholders including Friends groups/volunteers. The new computer program and scanned records are resources which help towards these goals.

Thank you to those who have supported the cemetery with donations. The money goes towards the upkeep of the cemetery and to pay someone for one hour each week to keep the cemetery looking tidy. Please keep your Lease (now called "Interment Right") document with your other legal papers. The Interment Right for a plot is for 50 years.

This year the annual newsletter was sent to 103 (mail) and 133 (email) contacts in September. To help keep down the administration costs, it would be appreciated if you could request an email version. Thank you.
